Submit your annual <u>Report of Abandoned Property</u> easily with Online Holder Reporting! Ideal for organizations with only a small number of unclaimed accounts to report, the Online Holder Reporting application allows you to enter information for 15 accounts on our secure website.

Enter the details for each owner and property you're reporting and a summary of your full report. We'll send you an email confirmation with a time and date stamp. Reference the stamp on your remittance to complete your report submission.

Be sure to provide the same information that you would include for other accepted reporting methods. Learn more in the <u>Handbook for Reporters of Unclaimed Funds</u>.
