# Local Sales Tax Collections Growth Improves in Third Quarter of 2019

## **Statewide Trends**


Local sales tax collections in New York State totaled \$4.8 billion in the third quarter of 2019, an increase of 6.3 percent over the third quarter of 2018. This growth was stronger than in either of the first two quarters of the year. (See Figure 1.) Year-to-date collections since January totaled \$13.5 billion, an increase of 4.3 percent over the same period in 2018.1


Economic factors that can contribute to sales tax growth appear generally positive, with consumer spending and wages continuing to rise.<sup>2</sup> Another influence on third quarter collections could be the implementation, in June 2019, of the new requirement that internet marketplace providers collect and remit New York State and local sales taxes on behalf of their out-of-State vendors.<sup>3</sup>

## **Regional Patterns**

Collections from January to September 2019 were the strongest downstate, with the Mid-Hudson (5.3 percent) and New York City (5.0 percent) leading all regions in year-over-year increases. Upstate, only the Capital District region had a growth rate that matched the statewide average of 4.3 percent.

Most other regions upstate experienced an increase in collections between 2.0 percent and 3.5 percent, while the Central New York region grew at only a modest 1.6 percent. (See Figure 2.)






## **County Collections**

County sales tax collections through the first three guarters of 2019 grew in 51 out of the 57 counties outside of New York City. This was a significant improvement compared to the first half of 2019, where collections declined in 15 counties over the same period the prior year.

Most downstate counties saw growth of over 3.0 percent, with the strongest in Westchester (7.3 percent). Certain upstate counties had fairly robust increases, including Rensselaer, Seneca and Washington. Yates County had the highest year-over-year increase of any county at 9.0 percent. (See Figure 3.)


Some of the declines - including those in Delaware, Hamilton and Fulton counties – were at least partially due to corrections made by the Department of Taxation and Finance (Tax & Finance) to collections from prior periods or late filing changes, rather than to actual declines in sales.4



## **City Collections**

Most of the State's 61 cities outside of New York City receive a share of what their respective counties collect, but 17 of them choose to impose their own general sales tax.<sup>5</sup>

Of these cities, three experienced a decline in collections through the first three quarters of 2019, with the largest decrease happening in Gloversville, followed by Olean and Oswego. The City of Oneida had the strongest growth, but it was mostly due to corrections made by Tax & Finance. (See Figure 4.)
